

Addendum no. [...] to Guarantee of [day] [month] [year] for Licence no. [...]

1. The Greenland Government and the Guarantor hereby make this Addendum no. [...] to the Guarantee.
2. In this Addendum, the following words and terms shall have the meanings stated below, unless otherwise apparent from or required by the context:
 1. "**Addendum**" means this addendum.
 2. "**Guarantee**" means Guarantee of [day] [month] [year] for Licence no. [...] [, as amended by Addendum no. [...] to the Guarantee].
 3. "**Greenland Government**" means the Government of Greenland (in Danish: *Naalakkersuisut*).
 4. "**Licence**" means the licence stated in box 1 below.
 5. "**Licensee**" means the licensee stated in box 2 below.
 6. "**Guarantor**" means the guarantor stated in box 3 below.
 7. "**Guarantee Amount**" means the guarantee amount stated in box 4 below. The Guarantee Amount stated in box 4 below may be the same as or different from the guarantee amount stated in the Guarantee and/or any former addendum to the Guarantee (if any).
 8. "**Effective Date**" means the effective date stated in box 5 below of this Addendum.
 9. "**Standard Terms**" means Standard Terms of 1 June 2019 for Guarantees regarding Licences Granted under the Mineral Resources Act.
3. In this Addendum, the words and terms defined in the Guarantee and the Standard Terms shall have the meanings thereby attributed to them, except where expressly stated otherwise in this Addendum.
4. This Addendum amends some of the terms of the Guarantee and/or any former addendum to the Guarantee (if any). This Addendum shall prevail over the Guarantee and/or any former addendum to the Guarantee (if any) to the extent this Addendum is not in accordance with the Guarantee and/or any former addendum (if any).
5. The Guarantee Amount stated in box 4 below shall apply on and from the Effective Date stated in box 5 below. This applies even if the Guarantee Amount stated in box 4 below is different from the guarantee amount stated in the Guarantee and/or any former addendum to the Guarantee (if any). However, the guarantee amount stated in the Guarantee and/or any former addendum to the Guarantee (if any) shall

continue to have effect and apply in relation to any instruction for payment under the Guarantee made by the Greenland Government to the Guarantor before the Effective Date of this Addendum stated in box 5 below if the guarantee amount stated in the Guarantee and/or any former addendum to the Guarantee is higher (greater) than the Guarantee Amount stated in box 4 below.

6. This Addendum is based on, subject to and governed by the Standard Terms. The Standard Terms shall apply to this Addendum, except where expressly stated otherwise in this Addendum.
7. This Addendum is made pursuant to the Licence, any applicable prospection plan, exploration plan, exploitation plan, closure plan and other plan for activities under the Licence and any approval by the Greenland Government of any such plan and any other applicable approval by and decision of the Greenland Government.
8. The boxes 1 to 5 below contain some of the specific terms of this Addendum.
9. Any agreed additional terms of this Addendum shall be stated in box 6 below. Box 6 may contain any relevant number of additional terms.
10. The Parties have signed this Addendum in two originals. Each Party shall have one of the originals.

All the required information must be stated in the boxes 1 to 5, in accordance with the text stated in italics in the boxes. Any additional terms of this Addendum must be stated in box 6.
